

Three Hundred Years of Psychiatry, 1535-1860. A History Presented in Selected English Texts.

By RICHARD HUNTER and IDA MACALPINE. This first fully documented chronicle of the beginnings of British psychiatry covers an unprecedented range of original source material, both printed and manuscript, from public and private archives. Since the rise of psychiatry is closely linked to social history and the humanities, Doctors Hunter and MacAlpine have combed not only the writings of physicians and psychologists, but those of jurists, philanthropists and philosophers, as well as reports of British Parliamentary Committees and the Statutes of Great Britain. Writers quoted include Sir Thomas More, King James I, Francis Bacon, William Harvey, John Locke, Robert Boyle, Daniel Defoe, Benjamin Franklin and Charles Dickens, in addition to many who are obscure and anonymous. Original spelling is used, and interesting title pages and bits of manuscript are reproduced.

A History of the Worshipful Society of Apothecaries of London. *Volume 1*, 1617-1815

Edited by E. ASHWORTH UNDERWOOD. The original text of this history by the late Dr. Charles Cameron (based on notes left by a former Master of the Society) has been revised and largely re-written. Dr. Underwood, basing his commentary on a detailed study of manuscript records and other extensive archives, traces the Society from its creation as a City Livery Company in 1617 through the first two centuries of its existence, when it was active in a large scale manufacture of drugs and the illegal practice of medicine. The work provides much new material about little-known apothecaries and physicians of note.
