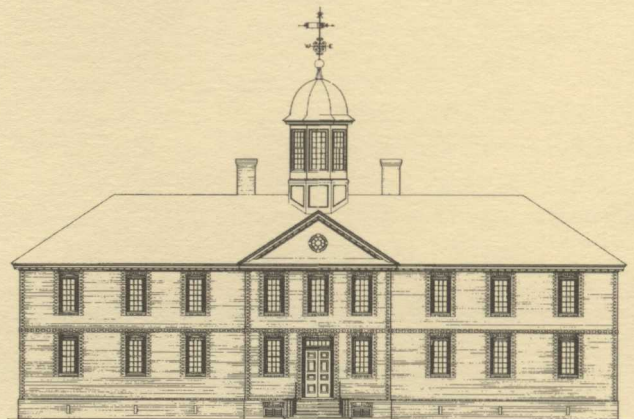

About the cover: The Public Hospital opened in Williamsburg in 1773 as the first hospital in British North America devoted exclusively to the care of the mentally ill. Dr. John de Sequeyra, who received his medical degree from the University of Leiden in 1739, served as visiting physician from 1773 until he died in 1795. The building, which has been reconstructed on the original site, is open to visitors.
